ORDER

(U/s 163 of the Bhartiya Nagarik Suraksha Sanhita, 2023)

WHEREAS, it has been brought to the notice of the District Authority that a few occupants of residential/ commercial/ industrial units are discharging their waste water/ grey water into the road side storm water drainages and in open fields;

AND WHEREAS, the discharge of water/ grey water in road side storm water drainages and open fields, causes serious negative effects on the environment, public health and can pollute local water sources, soil and vegetation;

AND WHEREAS, this type of pollution can harm local ecosystems, wildlife as well as causes spreading of epidemics of human being;

NOW THEREFORE, in exercise of the power conferred under Section 163 of the Bhartiya Nagarik Suraksha Sanhita, 2023, I, Priyank Kishore, District Magistrate, Dadra & Nagar Haveli, hereby order that on finding of such acts, legal action shall be initiated, which may include the withdrawal of occupancy certificate of such building disconnection of power supply.

The Public Works Department, Silvassa Municipal Council, Planning & Development Authority and District Panchayat are directed to conduct a survey and carry out an inspection and if any person or any commercial/ industrial unit is found to be in contravention of this order, seal it without any notice.

In view of requirements of the situation which is of an emergent nature, this order is being passed ex-parte and addressed to the general public.

This order shall come into force with immediate effect and shall be effective for a period of 60 days from the issue date of this order.

Any person contravening this order shall be punishable under Section 223 and Section 293 of the Bhartiya Nyaya Sanhita, 2023.
