ORDER

Whereas, the Ministry of Environment, Forest & Climate Change (MoEF & CC) notified the PWM Rules, 2016 (as amended), in exercise of the powers conferred under Section 3, 6 & 25 of the Environmental (Protection) Act, 1986 Vide Notification No. G.S.R. 320 (E) dated March 27, 2016; and

Whereas, MoEF & CC issued Notification, dated August 12, 2021 which mandated banning of identified SUP items and prescribed minimum thickness of carry bags with effect from July 01, 2022; and

Whereas, as per Rule 4 (2) of the PWM Rules, 2016 (as amended), "The manufacture, import, stocking, distribution, sale and use of following Single Use Plastic (SUP), including polystyrene and expanded polystyrene, commodities shall be prohibited with effect from the 1st July, 2022:

- (a) Ear-buds with plastic sticks, plastics sticks for balloons, plastic flags, candy sticks, ice-cream sticks, polystyrene [Thermocol] for decoration.
- (b) Plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping or packing films around sweet boxes, invitation cards, and cigarette packets, plastic or PVC banners less than 100 microns, stirrers; and

Whereas, as per Rule 4(1)(c) of the PWM Rules, 2016 (as amended) "Carry Bag made of virgin or recycled plastic, shall not be less than 75 microns in thickness with effect from 30th September, 2021 and 120 microns in thickness with effect from 31st December, 2022";

Whereas, the Central Pollution Control Board vide its letter dated 30.06.2022 has issued directions under Section 5 of the Environment (Protection) Act, 1986 to SPCBs / PCCs and UDDs for implementation of BAN on identified Single Use Plastics (SUP), wherein it was directed to setup a Control Room to facilitate activities related to the effective implementation of SUP Ban.

Now, therefore in compliance of the said Directions, Pollution Control Committee, DNH & DD has set up a **Control Room** to facilitate activities related to effective implementation of SUP Ban, the below mentioned staffs are hereby nominated to facilitate related activities in the territory of DNH & DD:
