- for installation of solar system and for that entire roof is to be change in tin shed which is very costly affair as in old roof the bearing capacity of the old roof is also required to be assessed
- As your good self is very well aware that, Industries are passing through the recession, so to divert working capital in to fix asset is very very difficult and for that, they have to obtain additional loan from the bank or financial institute.
  - The registration fee structure is very high the fee structure should be reviewed and should be very nominal to motivate the industries for installation of the solar system
  - As DNHPDCL is insisting for a security deposit of Rs. 5000/- per KW the contractors are recovering this amount along with the cost of the solar system which ultimately burdens to the consumer who voluntarily installs the solar system.
  - As the identification of the proper contractor, strengthening of the roof, obtaining a bank loan is the time-consuming process. The Administration and DNHPDCL should give adequate time for installation and completion of the solar system.
  - As pointed out many MSME's have no place for installation of the solar system, DNHPDCL may set up a common solar project for such MSME's units, so that they can contribute the proportional share and in our territory, we can have a common solar plant.

We hope that the Administration and DNHPDCL shall consider the above issues sympathetically and shall take an appropriate view in the interest of industries particularly MSME's
