Subject: Issues pertaining to Industries, which need your attention

Hon'ble Sirs,

We take this opportunity to bring following to your kind notice for considering and initiating effective appropriate measures:

1. Liberal view on Regularization of Constructions

Due to the issue of 10 KM area around wild life century in the UT, PDA is not granting the construction permissions. In hoping that matter will be resolved and industries will get the permission, many of our members have commenced the construction activities in accordance with the norms under DC Rules. When, the matter of ESZ will be resolved, the PDA will have to regularize those constructions. While regularizing, PDA will impose some penalty on technical

ground of commencing the construction activities before grant of construction permissions.

Sir, this violation is more of technical nature. The intention was not to disrespect the DC Rules.

Associations requests you to direct the PDA to take a practical approach and view the penalty provisions liberally to impose very nominal penalty, as it was not because of fault or ill intentions.

2. Validity of 7/12 and Certified Maps:

The PDA while processing the applications to grant construction permissions, is insisting for latest 7/12 and Certified Map of land not older than 30 days. It is requested to enhance this period to 12 months.

3. Visiting hours of Officers of D&NH Administration-

Visiting Hours of D&NH Administration's Officers for public have been changed to 2:30 PM to 3:30 PM from earlier one which were from 11:00 AM to 12:30 PM. The Associations have brought to your notice that new visiting hours are inconvenient to Industries. We request you to restore earlier one with following guideline to all Officers:

- a. Except in emergency, they must be available during the prescribed officers
- b. They should not have scheduled departmental or other meetings during the visiting hours.

4. Increase of VAT on item of Schedule-III from 4% to 5%:

Associations are taking up the matter at Ministry level for reconsideration. Meanwhile, it is going to result in blocking of huge working capital as our VAT refund process is very time consuming. In the UT like us where, collecting VAT results almost by 90% in refund, we must pay a serious thought to develop a mechanism for expeditious refunds.

We are sure that you will consider above issues and take suitable measures to let industries feel that Administration is determined to provide ease in manufacturing in the D&NH.
