Rajawat, District Magistrate, Dadra and Nagar Haveli in exercise of the powers conferred upon me by Section 144 of Code of Criminal procedure, 1973 (No. 2 of 1974) do hereby order that all the Owners / Managing Committees of Societies / Associations who are looking after the Management and Maintenance of the Multi Story Residential Housing Complexes are to install CCTV Camera at Entry Points/Gates of the said Multi Storey Residential Housing Complex and other vulnerable points thereat.

This order shall come into force with immediate effect from 05.12.2017 to 02.02.2018 (both days inclusive).

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.
