Sub:- Security Deposit

Respected Sir,

Many of our industries had paid the security deposit with the Electricity Department before formation of DNHPDCL. As they have surrendered their connections and have settled the dues and requested to refund the deposit which is kept with the DNHPDCL/Electricity Department. But the deposits of the consumers are not refunded by DNHPDCL since last one and half years without assigning any reason. Thus, the consumers money is blocked with DNHPDCL/Electricity Department in form of Security deposit, though they have already surrendered their connections and clear all the dues. So your kind honour is hereby requested to resolve the matter between DNHPDCL and Electricity Department to ensure that the consumers get the refund of their deposits at the earliest.

As per the Supply Code of JERC, the licensee DNHPDCL may take security deposit equivalent to two months average estimated bill. Till date the Department was keeping security deposit equivalent to one month average bill but now the Department has demanded additional security deposit equivalent to one month average consumption bill. It has brought to the notice of our association that, the DNHPDCL is not giving adequate

Due to this many of industries are facing the hardship because arrangement of fund in short time is not possible for them. Even as per Supply Code 6.10 (5) "On the consumer's request, the licensee may allow the consumer to pay additional security deposit in maximum three installments. So, considering the provision of Supply Code, your good self is hereby requested to adopt a lenient view in the matter and grant a reasonable time to consumers to enable them to arrange for the additional fund to pay additional security deposit.
