As you may be aware, at the 37th GST Council meeting, the decision was taken to implement the New GST Return from April 2020. This return system will contain simplified return forms for ease of filing. IMC had organized Workshop to discuss these forms and had sent suggestions collated during this Workshop to further facilitate the process.

The new forms are now available and with the objective of familiarizing members with this new return system, IMC Navi Mumbai has organised a special training cum guidance programme. Challenges, if any, pointed out during the course of this session, will be taken up by the GST Authorities who will be conducting the session.

- Forms to be filed under the new GST system
- Difference between current and new GST return system
- Input Tax Credit (ITC) under the new GST system
- Amendment returns under the new GST system
